Re: "The Coca-Cola Case"

Dear Mr. Winton:

I write on behalf of The Coca-Cola Company ("TCCC") concerning planned exhibitions of the film "The Coca-Cola Case" (the "Film") by Cinema Politica and/or its affiliates.

As litigation counsel for TCCC, I respectfully direct your attention to the enclosed letter issued by Judge Daniel Weinstein (Ret.), who mediated *In re SINALTRAINAL*, 01-cv-3208 (S.D. Fla.) and *Turedi v. The Coca-Cola Company*, 05-cv-9653 (S.D.N.Y.). The mediation is wrongfully and inaccurately described in the Film. (In fact, all of the allegations against The Coca-Cola Company and its bottlers were dismissed by each federal court that considered them.)

In addition to the obvious defamatory nature of the Film's descriptions, Judge Weinstein has found that certain statements in the Film by SINALTRAINAL representatives (Messrs. Kovalik, Collingsworth, and Correa) directly violate the conditions of confidentiality under which the above-referenced mediation took place, as well as the Final Order of the Settlement Master. Such confidentiality requirements are enforceable under the state and federal laws of the United States.

By receipt of this letter, you are hereby on notice of these confidentiality requirements, such that any further showing of the Film by or through Cinema Politica would be a knowing disclosure of



The Film El Caso Coca Cola includes references to a voluntary mediation process between SINALTRAINAL and TCCC (The Coca Cola Company) which took place under conditions of confidentiality established by state and federal laws of the United States and expressly by agreement among the parties. Statements made in the Film by Counsel for SINALTRAINAL referring to the purported contents, purported terms of mediation, and/or purported potential settlements directly violate confidentiality requirements and the Final Order of the Settlement Master requiring that contents of the mediation and negotiations between the Parties remain confidential.
